Briefing Report

Update

Welcome to my November "Briefing" Report.

I am sure all Councillors gained some further knowledge of the roles and responsibilities of Local Government Councillor from the recent LGAQ Conference in Cairns.

<u>General Business</u>, to assist in a smoother function and so you get an answer to each item, I offer the following solution which has worked in other shires.

- General business items are raised with the CEO by the Monday preceding the Council meeting
- On Tuesday, the CEO will collate the items raised and the (EMT) Executive Management Team will undertake to respond to each item raised by the start of the Council meeting on the Wednesday
- The list of items raised and subsequent answers will go to all members of Council.
- More than willing to undertake to give a full explanation at the meeting.
- An example will be tabled on the day.
- Further if an item then to be action, Council them can move a motion accordingly.

2 Operational Plan Matters

Operationally Council is progressing well through the strategies set by Council and Management have acknowledged the project priorities identified by Council at a recent Workshop. An update on implementation of the Operational Plan is part of a separate report in the Council Agenda.

As previously advised, Council have enlisted 2 Project Managers. It is endeavored that these positions will be filled with fulltime staff in the near future.

- 1. Alan Clark
 - a. Charleston Dam (Fish Ladder, Fencing, Walking Trail, Security and Telemetry, Etc.)
- 2. Robert Jaggar
 - a. Housing (Independent Living, Staff, Sports Centre and Asset Management, Etc.)

3 Immerging Issues

Going by the BOM, there is a higher than average chance of greater rain within the Shire area over the next few months (wet season).

Early rains are predicted and Management are shuffling projects to enable delivery.

Rest assured Council is prepared. Council has recently held a LDMG meeting run a successful exercise to test the Charleston EAP and the Local Disaster Management Plan. It has been raised that there needs to a more appropriate Control Centre for the LDMG during floods and a river gauge on the Etheridge River. Minutes of the LDMG Meeting are in the Council Agenda.

4 Projects

I am currently working on the following projects, and if you have any comments do not hesitate to ask.

• Charleston Dam - Alan Clark

- Boundary fencing is being constructed
- o Any alterations of land tenure or use requires Native Title consideration
- o Telemetry design has been finalised and should be installed soon.
- Fish Ladder, expecting delays
- EAP, is subject to a GHD report on safety inspection and dam height issues
 - Will work remotely to see these technical issues resolved.
- A Walking trail around the dam and to Forsayth has been identified and is being cleared, this may link to future cycle network

Housing – Robert Jaggar

- Staff housing
 - As above, putting out feelers and clarifying design options
- Staff units
 - Developing a proposal to place 3 * 1 bedroom units in High Street.

 Further to the report in the information agenda, the issue of gravel pits and their location is becoming a major hurdle. Council have been working with Pixie Hughes to resolve any outstanding issues.

- o Council have received notice of funding for a wash-down facility in Georgetown

Regional Drought Resilience Planning Program – Round 2

I am writing to formally invite Etheridge Shire Council to be a partner in the Regional Drought Resilience Planning (RDRP) program in Queensland. This program is jointly funded through the Queensland Government and the Federal Government's Future Drought Fund.

The Queensland Department of Agriculture and Fisheries has partnered with the Rural Economies Centre of Excellence (RECoE), comprised of four Queensland research institutions, to deliver the RDRP.

The purpose of the program is to help regions plan to survive and thrive into the future in the face of drought. RECoE will lead consultation, working with regional communities, to develop Regional Drought Resilience Plans to prepare for and manage future drought risks. While a regional organisation for your area will be our lead partner, your Local Government Area (LGA) will be key to the success of the regional drought resilience planning process.

The planning will also align with the Queensland Strategy for Disaster Resilience and its implementation plan, Resilient Queensland, led by the Queensland Reconstruction Authority – who continues to support this program as a key stakeholder.

As part of the Far North Hinterland to Gulf region, your LGA is invited to be involved in the consultation and development of a Regional Drought Resilience Plan by 30 June 2024.

The plans are to identify actions to prepare for future droughts, with a sharp focus on the agricultural sector and allied industries.

The RDRP Program will support development of the plans by providing access to evidence and data, independent expert feedback, as well as the opportunity to learn from the pilot year and collaborate with regions in this second round.

Genex Power Limited (Genex) has requested the Genex Kidston Wind Farm Project (the project) be declared a prescribed project under section 76E of the *State Development* and *Public Works Organisation Act* 1971 (SDPWO Act).

I am inviting all agencies who may have a role in regulating approvals for the project to make a written submission regarding the proposed prescribed project by 18 November 2022.

The project

The proposed \$572.5 million project involves the construction of a 250MW wind farm in Kidston (Lot 182 on PH995, Lot 14 on LH8, Lot 66 on SP30495 and Lot 2 on SP28310). The project forms stage 3 of the Kidston Clean Energy Hub, which Genex considers will be the world's first integration of large-scale solar generation with pumped hydro storage and wind energy at a single hub location.

The project consists of approximately 43 wind turbine generators, construction of an access route and transmission line, transport route upgrades, and ancillary facilities. Completion of the project is anticipated to generate 575 GWh/a by connecting into the new 275 kV transmission line being constructed by Powerlink Queensland. The project is expected to increase the energy grid reliability of the North Queensland region and create approximately 200 jobs during construction and 10 jobs during operations.

Genex is currently undertaking route surveys for construction traffic and routes from both Cairns and Townsville ports are under consideration.

Declaration of a prescribed project

The Minister may, by gazette notice, declare a project to be a 'prescribed project'. A prescribed project is one which is of significance, particularly economically and socially, to Queensland or a region.

The Coordinator-General may give notices to a decision maker responsible for making a decision on the development of a prescribed project (for example issuing an approval), to ensure timely decision making.

The decision maker may be a State Government agency, local government or a government owned corporation responsible for providing approvals, permits or authorities. The Coordinator-General cannot issue a notice relating to a decision to be made by the Governor in Council, another Queensland Minister, the Commonwealth Government or a court of law.

In deciding whether to declare a prescribed project the Minister may consider:

- public interest or the general welfare of persons in the region in which the project is to be undertaken
- whether a voluntary environmental agreement under the SDPWO Act is likely to be entered into to help manage potential environmental effects from the project
- other matters considered relevant.

As the owners of the Goldfields Hotel and Finnigan's Rest Forsayth, we would like to express our interest in operating a tourism venture on the Charleston Dam, Forsayth, in the form of a Cruise Boat. We would like to offer a range of cruises, including but not limited to, sunset cruises, possibly with onboard BBQ or food options, lunch time cruises or even sunrise cruises.

We see this as a natural extension of the tourism offerings we have developed in Forsayth being: Forsayth By Night, a walking ghost tour, hotel meals and accommodation and transfers for visitors and locals to our region and surrounding tourism attractions such as the Gulflander and Savannahlander trains and Cobbold Gorge.

We have the infrastructure in our 35-seater coach based in Forsayth to transfer people to and from Forsayth to Charleston Dam, allowing for reduced wear on the roads and emissions, and for guests to be able to enjoy themselves without the concern of drink driving, keeping our communities safer.

Forsayth has a history rich in gold, mining and the railways and we would like to share these stories with visitors to appreciate the difficulties and hardships the pioneers and early settlers lived through in order for us to live and enjoy the beautiful region in which we live and work.

In order to offer such a tourism product we would require mooring facilities at Charleston Dam for an approx. 35 seat twin hull vessel. We envisage a requirement of 2 x 25hp outboard motors to safely navigate around the dam. The vessel design will consciously incorporate access for mobility impaired visitors to the best of our ability to provide an accessible tourism opportunity.

Our sister business Cobbold Gorge is an Advanced Ecotourism Business and through the development of both Cobbold Gorge and the Goldfields Hotel, the main criteria is that the operation be conducted with minimal environmental impact. As members of the Savannah Guides we focus on the protection, sustainability and interpretation of the land on which we operate.

We therefore request approval from Council to conduct guided scenic cruises on Charleston Dam for locals and visitors to our community.
