1 Overview

The Australian Government has committed \$2.5 billion to assist state and territory governments (the states) in the construction of major water infrastructure.

The Government will provide:

- \$2 billion in concessional loan funding for the **National Water Infrastructure Loan Facility**
- \$440 million in capital funding for the **National Water Infrastructure Development Fund Capital Component**, including \$170 million for water infrastructure in northern Australia

These guidelines apply ONLY to the National Water Infrastructure Development Fund - Capital Component

The National Water Infrastructure Development Fund (the fund) was announced through the White Papers on Agricultural Competitiveness and Developing Northern Australia, available from agwhitepaper.agriculture.gov.au and industry.gov.au/ONA/WhitePaper/index.html respectively.

This call relates exclusively to the capital component of the fund, with \$192.5 million available. Expressions of Interest (EOIs) will be accepted continuously from October 2016 until all funds are committed.

Applications received by 3pm 16 March 2017 will be assessed for funding prior to 1 July 2017.

Applications received after this date but before 3pm 17 August 2017 will be assessed for funding prior to 1 November 2017.

The department may alter the above dates for this EOI process. States will be informed by the Fund team of any changes to the assessment dates.

Only states, as the project proponent (proponent), may apply for funding. States may act in partnership with other organisations.

Proponents do not need to have received funding through the feasibility component of the fund to apply for capital funding. Studies funded through the feasibility component are not guaranteed capital funding.

Projects must be ready to progress to construction to be considered for funding.

2 Objective and outcomes

2.1 Objective

The Australian Government will work in partnership with the states to support long-term regional economic growth and development by providing secure and affordable water through

investments in economically viable water infrastructure that will be managed in accordance with the principles of the National Water Initiative (NWI).

Ensuring sufficient and appropriately treated water for critical human needs is a core responsibility of states, and as such, water infrastructure primarily for urban and potable use is outside the scope of the fund.

2.2 Outcomes

The fund will have the following outcomes:

- the construction of economically viable water infrastructure, including but not limited to dams, weirs, pipelines, managed groundwater recharge and water treatment and reuse schemes
- the provision of access to secure and affordable water to underpin regional economic growth, including irrigated agriculture and industry.

2.3 Structure of the fund

There are two components to the fund:

- Feasibility component: The feasibility component is now closed, with \$59.5 million provided for 39 feasibility studies. More information is available at agriculture.gov.au/water/national/national-water-infrastructure-development-fund
- Capital component: \$440 million over eight years from 1 July 2017, including a component for northern Australia of up to \$170 million.

Funding for the capital component will be provided as follows:

- \$247.5 million to the projects announced as 2016 election commitments, including up to \$130 million for northern Australia
- \$192.5 million through this EOI process, including up to \$40 million for northern Australia.

Funding will be allocated to eligible infrastructure projects on a merit basis until all funds are committed.

2.4 How will the Australian Government invest?

The Department of Agriculture and Water Resources (the department) will deliver the fund on behalf of the Australian Government.

Only states, as the project proponent (proponent), may apply for funding. States may act in partnership with other organisations.

Funding will be prioritised towards water infrastructure that, if developed, will provide affordable and secure water supplies to support the growth of regional economies and communities and focus on water infrastructure that:

- is economically viable over its proposed operational life
- aligns with the fund's objectives
- is consistent with relevant Australian Government policies
- has all relevant Commonwealth and state regulatory and planning approvals in place

- has matching funding commitments approved by the state
- represents value-for-money for Australian Government funds
- is supported by a clear and credible business case.

Preference will be given to water storage infrastructure including the construction of dams and weirs that deliver broad public benefits through increasing regional water availability and security for water users.

3 Eligibility

3.1 Eligibility criteria

- Only state and territory governments may apply for funding.
- Only proposed water infrastructure projects ready to progress to construction are eligible for funding.
- EOIs must have the support of the state minister responsible for water.
- States must commit to implementation of NWI consistent water management in the catchment where the infrastructure is proposed, available at agriculture.gov.au/water/national/national-water-infrastructure-development-fund.

3.2 Eligible funding types

Eligible activities include construction or enhancement of major water infrastructure including, but not limited to:

- dams, weirs and pipelines
- managed groundwater (aquifer) recharge
- water treatment and reuse.

3.3 Ineligible funding types

Examples of activities ineligible for funding include:

- retrospective activities (activities that have already been conducted)
- pre-feasibility and feasibility activities
- activities undertaken for safety upgrade purposes / dam safety upgrades
- infrastructure or upgrades chiefly for recreational / social purpose
- water infrastructure primarily for urban and potable use
- infrastructure that is related or associated but is not chiefly water infrastructure, including but not limited to roads, rail and energy and communication networks
- activities funded / intended to be funded using another Australian Government source
- debt restructuring / re-financing of existing debt
- ongoing operational and maintenance costs
- purchase of land

- business as usual operation and administration costs of the state, including staffing, of the organisation delivering the construction project. This does not extend to consultants or contractors engaged specifically and solely for the purposes of the project.
- anything deemed by the department to be contrary to the objectives of the fund.

3.4 Funding terms and conditions

- The department will cease accepting EOIs once funds have been fully allocated.
- Funding will be delivered through a National Partnership Agreement (Agreement).
- Funding will be on a treasury-to-treasury basis, as per milestones in the Agreement.
- Australian Government contributions from all sources will not exceed 50 per cent of the total project cost.
- In-kind contributions cannot form part of the non-Australian Government contribution.
- Projects must be completed by 30 June 2025.
- Projects requesting \$100 million or more in Australian Government funding will be referred to Infrastructure Australia for economic review.

3.5 Funding guarantees

Projects must be either ready to commence construction or undergoing final approvals requirements at the time the EOI is lodged with the Australian Government — that is, construction can commence within six months of funding being agreed.

The Australian Government will consider EOIs for projects close to construction (for example, where feasibility and environmental studies have been completed and financing options are being examined). In these cases, successful offers would be subject to conditions and timeframes imposed by the Australian Government and these would be set out in a schedule to the *National Partnership Agreement on National Water Infrastructure Development Fund – Capital Component* (the Agreement). The funding guarantee may be withdrawn and reassigned by the Australian Government to another national project of its choice if the conditions are not satisfactorily met within the specified timeframes.

Once the conditions are met and construction commenced, funding would be provided as per milestone conditions in the bilateral schedule to the Agreement.

4 Expressions of Interest

4.1 How to apply

EOIs must be made on the form available from <u>agriculture.gov.au/water/national/national-water-infrastructure-development-fund</u>. Proponents may not alter the EOI form.

An electronic, signed copy of the EOI form must be forwarded to the department at waterinfrastructure@agriculture.gov.au. EOIs will be accepted and assessed continuously until all funds are committed.

Applications received by 3pm 16 March 2017 will be assessed for funding prior to 1 July 2017.

Applications received after this date but before 3pm 17 August 2017 will be assessed for funding prior to 1 November 2017.

The department may alter the above dates for this EOI process. States will be informed by the Fund team of any changes to the assessment dates.

For EOIs, including attachments, under 20 MB, please email through to waterinfrastructure@agriculture.gov.au. For EOIs 20 MB or over, please contact the department via this email to discuss how to transmit it.

One EOI should be submitted for each water infrastructure project. Each project must be on a separate EOI form.

The department reserves the right to change the EOI process. States will be informed of any changes.

4.2 Information required for assessment

All EOIs must be accompanied by a comprehensive business case, supported by robust evidence, confirming the need for the infrastructure, including a detailed cost-benefit analysis. Copies of studies, plans, reports and/or decisions and/or approvals that support or form part of the business case should be provided with the EOI.

The EOI form available from the website <u>agriculture.gov.au/water/national/national-water-infrastructure-development-fund</u>) details the information required from proponents. Some critical information to include is as follows:

- the amount of funding sought from the Australian Government (exclusive of GST)
- a breakdown of proposed auditable funding contributions (exclusive of GST) from all sources (contributions can be sourced from any legal entity, including state and/or local government and the private sector)
- a clear description of the proposed project, including its location, proposed commencement and completion dates and the nature of the work to be undertaken
- a description of how the proposed project aligns with the objectives of the fund
- whether funding will be sought from another Australian Government source e.g. the Northern Australia Infrastructure Facility, the National Water Infrastructure Loan Facility or the other Commonwealth programs.

4.3 Mandatory assessment criteria

Proposed projects must address all the mandatory assessment criteria outlined in Table 1. The department reserves the right to seek external advice and use the information provided in the EOI for this purpose.

Table 1: Mandatory Assessment Criteria

		In considering public benefit, preference will be given to those projects that will:

5 Conditions for applying

5.1 Application and assessment process




Figure 1: Application and Assessment Process

The department will evaluate EOIs against the criteria set out in the guidelines and will seek advice on EOIs from relevant experts as required, including through the establishment of a water infrastructure expert panel. EOIs seeking funding of more than \$100 million will also be referred by the department to Infrastructure Australia for economic evaluation.

The Water Infrastructure Investment Governance Board will be established by the department to provide advice and recommendations on the merit of EOIs against the mandatory assessment criteria.

The department will use this advice in making recommendations to the Minister for Agriculture and Water Resources on the merits of projects for funding.

5.2 False and misleading information

Project proponents should be aware that the intentional giving of false or misleading information is a serious offence under the *Criminal Code Act 1995*.

5.3 Confidential information

Project proponents must identify any information contained within their EOIs or in any documentation that they consider should be treated as confidential and provide reasons for the request. The department reserves the right to accept or refuse a request to treat information as confidential.

Information provided to the department that has not been accepted as confidential may be shared or published, as determined by the department.

Confidential information may be released as required by law or Parliamentary privilege.

5.4 Freedom of Information

All documents in the possession of the department, including those in relation to the EOI and proposed construction projects under the fund, are subject to the *Freedom of Information Act 1982* (FOI Act).

The FOI Act creates a general right of access to documents in the possession of the department. Unless a document falls under an exemption provision, it will be made available to the public if requested under the FOI Act.

5.5 Privacy Statement

Personal information means any information or opinion about an identified, or reasonably identifiable, individual.

The collection of personal information by the department in relation to this EOI is for the purposes of assessing EOIs for the capital component of the fund, evaluating the fund and related purposes. If the relevant personal information requested in this EOI is not provided, the department may not be able to assess the EOI.

Personal information may be disclosed to relevant parties engaged for the purposes of assessment of EOIs and fund evaluation, the Minister and the Minister's office, on the department's website and to other Australian Government agencies, persons or organisations where necessary for the above purposes, provided the disclosure is consistent with relevant laws, in particular the *Privacy Act 1988*. Personal information will be used and stored in accordance with the Australian Privacy Principles.

5.6 Corrections

The department will not accept responsibility for any misunderstanding arising from the failure by a state to comply with the guidelines or arising from any discrepancies, ambiguities, errors or inconsistencies in an EOI.

If a project proponent discovers any material discrepancy, ambiguity, error or inconsistency in their EOI, they must immediately bring it to the attention of the department by email at waterinfrastructure@agriculture.gov.au. The department may, at its discretion, allow a state to remedy any discrepancy, ambiguity, error or inconsistency.

6 Administration of Funding

6.1 Notifications of funding decisions

Decisions on EOIs will be made as soon as practicable after receipt, noting that all EOIs will be subject to analysis and consideration by the Australian Government before an offer of funding is made.

Project proponents will be notified of the outcome in writing.

The Australian Government reserves the right to negotiate the scope of a project under the fund.

The Australian Government reserves the right to impose conditions on projects that must be met before funding is provided.

6.2 Funding conditions

- Funding will only be provided to states through an Agreement in accordance with the Federal Financial Relations framework. Payments by the Australian Government will be to states on a Treasury-to-Treasury basis in accordance with the Agreement.
- A separate schedule to the Agreement will be required for each state. These schedules will set out the agreed objectives, activities and reporting and payment schedules for individual construction projects.
- The Agreement and schedule must be signed by the relevant state before payments are made
- If a state is offered a funding guarantee, the schedule will also set out the conditions and timeframes to be met before funds are transferred.
- The department will manage the Agreement and schedules. The Minister for Agriculture and Water Resources will make decisions in consultation with states regarding variations.
- Successful project proponents will be responsible for managing the project within agreed timelines, including submitting progress reports to the department.
- Funded projects must acknowledge the funding support provided by the fund in accordance with the recognition guidelines (see section 6.5).
- Departmental officials and others may contact project proponents during or after the life of the fund.
- Project proponents must obtain the agreement of the department in relation to, and prior to, any planned media event relating to the funded infrastructure.

• Requests for ministerial or departmental representation at launches and functions relating to the funded construction projects must be coordinated through the fund team.

6.3 Publication of information about successful projects

The Australian Government may publish the following information in a variety of media about successful projects:

- the state receiving the funding, along with the project's title and purpose
- anticipated outcomes and benefits of the infrastructure
- amount of funding received
- term of the funding
- funding location
- information on progress as reported to the department.

The Agreement and schedules will be published in full on the Council on Federal Financial Relations website.

By submitting an EOI, project proponents consent to the above information being publicly shared should they be awarded funding.

6.4 Reporting requirements

The Agreement and associated schedules will detail the reporting requirements for funded projects.

6.5 Recognition guidelines

In all publications, promotional materials, signage and activities relating to the funding received, recipients must acknowledge the financial and other support it has received from the Australian Government by including the words:

This project is supported by funding from the Australian Government National Water Infrastructure Development Fund, an initiative of the Northern Australia and Agricultural Competitiveness White Papers.

All publicity, announcements and media releases relating to the project should be forwarded to the department for its records.

7 Other information

7.1 Unsuccessful proposals

Project proponents will be notified in writing where an EOI is ineligible or unsuccessful. Proponents may contact the department to obtain feedback on their EOI.

7.2 Complaint handling process

There is no appeal mechanism for unsuccessful EOIs, and EOIs will not be reviewed.

If a proponent is dissatisfied with the way an EOI has been handled by the department, they can contact the fund team at waterinfrastructure@agriculture.gov.au and lodge a complaint.
