Legal Matter - Rates 2014/15

#### EXECUTIVE SUMMARY

Council requested management on the 17 September 2014 to seek independent legal advice regarding the allegation against Council regarding its Differential Rating Groups and once Council had received this opinion from its legal counsel that the matter be brought back to Council for further deliberations regarding this allegation. Council received its Legal Advice / Opinion from Council's legal representatives dated 5 November 2014 to allow Council to deliberate further regarding this matter.

From the advice obtained from Council's legal counsel, Council issued a notice of non-payment with the intent that if payment was not received within 30 days then Council <u>may commence</u> proceedings in the District Court to recover the unpaid rates as a debt.

Council has received a reply from the entity on the 18 December 2014 which was received at Council on the 5<sup>th</sup> January 2015.

#### EXECUTIVE SUMMARY

Aeramix have been engaged to undertake process assessments, process and concept design, and construction of a water treatment plant to overcome elevated levels of Manganese (Mn) in the Raw water supply.

The initial project concept was to utilise excess process equipment from a Water Treatment Plant construction in Richmond QLD and the process assessments were designed to accommodate that.

The systems at Richmond were de-mounted skid based units which were to be reassembled for use in Georgetown for temporary installation and operation in a manual mode. Project budget costings for delivery of a temporary system were provided by Aeramix and accepted by Etheridge Shire Council in October 2014 and broken into four main components being;

- 1. Process assessment and design,
- 2. Detailed design (excluding design drawings and drafting) and construction,
- 3. Commissioning and documentation, and;
- 4. Variations

**Dust Seals** 

#### EXECUTIVE SUMMARY

At the October 2014 General Council Meeting it was resolved to permit the Director of Engineering time to investigate criteria relevant to providing 'dust seals' adjacent to homesteads and also to address the type and estimated cost of seals best suited for dust suppression.

In the course of investigating a criterion for the provision of dust suppression at a location, it was noted that many councils throughout Queensland and New South Wales have in fact instigated a

policy (more an Administrative Direction) regarding laying dust suppression seals on roads adjacent to homesteads. This work in general is carried out by the relevant Council with the costs borne by the Applicant i.e. similar to ESC's private works order procedure.

Criteria that is relevant to making an informed decision regarding laying a 'dust suppression' seal on a road include volume of traffic and type of vehicle, vegetation surrounding the homestead, distance of the homestead from the road, prevailing winds and quality of existing road.

The type of "seal" treatment process to be used is weighted against cost, extent of usage of the road and period of durability.
