General:

1) The proposed development shall be undertaken substantially in accordance with the approved drawings and/or documents and in accordance with the specifications, facts and circumstances as set out in the application submitted to Council and referenced in the following schedule except as otherwise specified by any condition of this approval:

- 2) The conditions of the Development Permit must be affected prior to Commencement of Use, except where specified otherwise in these conditions of approval.
- 3) The applicant will ensure as far as practicable that access to the site by the public during construction shall be limited as far as practicable by way of temporary construction fencing and gates to a height of 1800mm.
- 4) During construction phase any damages to the road reserve (i.e. footpath/kerb and channel and or adjacent road surface) must be replaced and or repaired by the developer in accordance with council standards.

Time and Effect:

5) The Development Approval shall lapse four (4) years after the date the Development Approval takes effect in accordance with the provisions of Section 341 of the Sustainable Planning Act 2009 and Section 3.5.21 of the Integrated Planning Act 1997.

Fencing:

- 6) The applicant shall provide an appropriate and adequate fence to the boundary of the property prior to commencement of operations of the proposed business.
- 7) Consultation with adjoining property owners is essential so an amicable agreement is achieved in respect to the type, shared cost and proposed installation of a fence on a common boundary.

Site Appearance:

- 8) All materials and machinery to be used during the construction period are to be wholly stored on the site, unless otherwise approved by Council.
- 9) The site is to be kept in a clean and tidy condition at all times both during construction periods of any infrastructure and normal business operations to the satisfaction of Council.

Landscaping:

10) The applicant shall within 3 months of commencement of operations provide tree/shrub vegetation that is compatible with the regional vegetation such that it provides partial

screening of their operations from Cumberland Street and Hayman Street and neighbouring properties.(refer "Appendix C")

Noise:

- 11) The hours of audible noise associated with construction and building work on site must be limited to between the hours of:
 - *i.* 6.30am to 6.30pm Monday to Saturday
 - ii. No work on Sundays or Public Holidays.

Dust Suppression:

12) The applicant shall ensure that measures are installed and or implemented to ensure that the suppression of dust and any other wind-blown debris from the site does not cause environmental nuisance to adjoining properties.

Access to Lot:

13) The applicant shall provide driveway entry and exit crossovers in approved locations (refer "Appendix C – Landscaping Plan and Figure 3 - Position of Shed with Driveway into and Exiting Shed"). This work shall be carried out in accordance with council standards and to the satisfaction of councils' Engineer.

Services:

14) The Applicant shall be responsible for the cost of necessary alterations to existing public utility mains, services or installations required by works in relation to the proposed development or any works required by condition(s) of this approval.

Drainage:

15) Soil and water management measures must be installed / implemented prior to discharge of water from the site, such that no external stormwater flow from the site adversely affects surrounding properties (in accordance with the requirements of the Environmental Protection Act 1994). The lawful point of stormwater discharge is Sandy Creek.

Car Parking:

16) The applicant shall make provision for sufficient car parking spaces within the boundaries of the development suitable in number for the type and operations of the proposed business.

On-Site Sewerage:

17) Waste disposal shall be by way of a minimum Secondary Standard Waste Water Treatment Plant and associated land application area. Prior to construction a site and soil report with associated effluent design shall be lodged with council for prior approval.

Flammable and Combustible Liquids:

- 18) Spillage of all chemicals, fuels and lubricants must be contained within an on-site containment system and controlled in a manner that prevents environmental harm.
- 19) All petroleum product storages must be designed, constructed and maintained in accordance with AS-1940 Storage and Handling of Flammable and Combustible Liquids.

Other Matters:

20) This development approval does not permit any building or plumbing works to be carried out prior to the appropriate approvals for such works being obtained.

EXECUTIVE SUMMARY

At its December 2015 General Meeting (Item No: GMCCS11) Council resolved to approve a Permissible Change to the previously approved Forsayth Wind Farm development Council has on 08 March 2016 received further correspondence from the applicant seeking further amendments to conditions and site layout of the development.

In summary the applicant seeks to change the approved layout of the wind turbines and amend/ remove the requirement of Condition No.12.

Furthermore the applicant has proposed certain developer contributions for councils and the community's benefit.

Under normal circumstances this request would be a Permissible Change under the Sustainable Planning Act (SPA). However due to the short time frame from receiving this correspondence, the need for this request to be referred to Government Departmental Agencies, the applicant seeking urgent advice and the need for council to decide on certain matters a formal Permissible Change Application will be submitted by the applicant at a later date.

This report identifies specifically the applicant requests which can and are governed under SPA.

RESOLUTION:

Accepts the officers' report and furthermore resolve to approve the following recommendations in relation to the changes sought to original conditions of approval through this request for change:

1) Existing Condition 12 states:

"The road shall be bitumen sealed for the full length of the frontage of the Einasleigh - Forsayth Road and associated access road intersections"

The applicant's request suggests that through diligent planning and construction of internal road

ways and access points to these roadways the need for the applicant to utilise unsealed sections of the Forsayth-Einasleigh Road will be negated.

It is recommended that council resolve to approve the following amendment to condition 12:

"The road shall be bitumen sealed for the full length of the frontage a minimum of 5km of the Einasleigh - Forsayth Road and associated access road intersections"

2) Project Layout and Existing Condition 1:
