Internal Review - Gorge Creek Weir

EXECUTIVE SUMMARY

It has been claimed that the owner of a cattle station has constructed a weir across a waterway without permission. The weir causes water to back over the Dulthara road crossing and restrict access to people using the road. Enquiries with the Department of Natural Resources and Mines revealed that the weir had originally been built in 1946 at a lower level but had washed out in 2006. They also advise that prior to the weir washing out it had been full of sand and the Dulthara road crossed over the backed up sand. When the weir failed all the sand in the weir also washed out and the Dulthara road crossing was lowered as a result of the sand level being carried away. When the weir was reconstructed in 2014, it caused water from the creek to back up over the Dulthara road crossing, restricting access.

The Station owner has been sent correspondence from the Department of Natural Resources and Mines requiring him to either decommission the weir or apply to have it authorised under the Water Act. Users of the Dulthara Road believe that former Council Engineer, Rohana Samarasekera had been authorised to cut through the weir, but that work did not release sufficient water to satisfy the users.

The matter has been referred to the Department of Natural Resources and Mines as it is believed that this matter falls under their jurisdiction. Council must follow the 'rule of law' and cannot trespass onto someone's land and destroy his property (whether the structure has approval or not).

Mosquito populations fluctuate from year to year (as well as seasonally) in response to changing environmental conditions. Flexibility in Council's response will provide the most effective outcome and approaches to mosquito management can be direct or indirect.

Direct mosquito management interventions include the removal of breeding habitat by:

- physical modification (eg improving roadside drainage);
- introduction of biological controls (for example, fish into water storages); and
- application of pesticides.

Indirect approaches reduce exposure to mosquitoes, for example:

- utilising planning mechanisms to create adequate buffers around wetlands; and
- educating the public to avoid mosquitoes.

Charleston Dam - Land Negations
